City Council Minutes of Meeting April 9, 2020 6:30 p.m.

The City Council of the City of Farmington met via telephone on April 9, 2020. The meeting was conducted via telephone conference call due to the COVID-19 emergency response protocols.

The meeting was called to order by Mayor Forsythe.

Councilor Linnenbringer made a motion for the minutes to reflect the meeting being held telephonically due to the current COVID-19 pandemic and gathering restrictions put in place by the Governor of Missouri and the St. Francois County Commission, seconded by Councilor Pegram, and passed unanimously.
