

# **CITY OF FARMINGTON**

## **City Council Minutes of Meeting September 10, 2020 6:30 p.m.**

The City Council of the City of Farmington met on September 10, 2020, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640.

The meeting was called to order by Mayor Forsythe.

John Robinson gave the invocation.

The roll was called with the following Councilors present: Harry Peterson, Wayne Linnenbringer, Chris Morrison, Vanessa Pegram, Tom Joyce, Adam Parks and Edward Felker.

City Counselor, Scott Reid, was present.

Officials present were: Todd Mecey, Tim Porter, Ashley Bischoff, Greg Beavers, Rick Baker and Larry Lacy.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer and passed unanimously.

Mayor Forsythe presented a service award to John Robinson for his service as Ward I City Councilor from 2011-2020.

Mayor Forsythe presented a proclamation to Whitney Shumway for National Suicide Prevention Week.

Nancy Cozean Jacob, 117 Ohio Court, addressed the Council to give them an update and thank them for their support on the Bicentennial project.

Reports were given by Committee Chairs with discussion.

Councilor Felker made a motion to hire Tyler Ury as a Police Officer, seconded by Councilor Pegram, and passed unanimously.

Greg Beavers, City Administrator, reported on Farmington Electric Utility Wholesale Energy and Transmission and answered questions from the Council.

Councilor Pegram made a motion to approve the consent agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Resolution passed unanimously.

Councilor Pegram made a motion for the first reading by title only of Bill 31092020, seconded by Councilor Parks, and passed unanimously.

Counselor Reid read the following Bill once by title only.

**BILL 33092020: AN ORDINANCE AMENDING THE GENERAL ZONING ORDINANCE AND ACCOMPANYING MAP THERETO AND KNOWN AS GENERAL ORDINANCE 11-21 BY CHANGING THE CLASSIFICATION OF THE ZONE DISTRICT FOR CERTAIN PARCELS OF LAND DESCRIBED HEREIN (125 WEST KARSCH BOULEVARD – CASE REZ-20-006).**

Councilor Pegram made a motion for the reading of Resolution R50-2020 by title only, seconded by Councilor Linnenbringer, and passed unanimously.

Counselor Reid read the following Resolution by title only.



Ashley Bischoff, City Clerk, administered the Oath of Office to David Kennedy, Ward I City Councilor Appointee.


Councilor Pegram made a motion to adjourn, seconded by Councilor Linnenbringer, and passed unanimously.
