City Council Minutes of Meeting November 23, 2020 6:30 p.m. *Revised*

The City Council of the City of Farmington met on November 23, 2020, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640.

The meeting was called to order by Mayor Forsythe.

Councilor Joyce gave the invocation.

The roll was called with the following Councilors present: Chris Morrison, Vanessa Pegram, Tom Joyce, David Kennedy, Adam Parks, Chad Follis, Harry Peterson and Wayne Linnenbringer.

City Counselor, Scott Reid, was present.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Councilor Pegram made a motion for the second reading by title only of Bill 42112020, seconded by Councilor Linnenbringer, and passed unanimously.

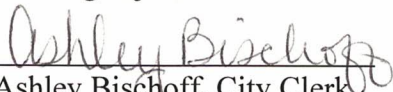
Counselor Reid read the following Bill once by title only.
