

CITY OF FARMINGTON

City Council Minutes of Meeting January 25, 2021 6:30 p.m.

The City Council of the City of Farmington met on January 25, 2021, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Councilor Linnenbringer gave the invocation.

The roll was called with the following Councilors present: Keli Keutzer, David Kennedy, Adam Parks, Chad Follis, Harry Peterson, Wayne Linnenbringer and Chris Morrison.

City Counselor, Scott Reid, was present.

Officials present were Greg Beavers, Ashley Bischoff, Todd Mecey, Travis Trokey, Paula Cartee, Tim Porter, Larry Lacy and Michelle Daniel.

Councilor Linnenbringer made a motion to approve the agenda, seconded by Councilor Morrison, and passed unanimously.

Mayor Forsythe and City Administrator, Greg Beavers, presented service awards to city employees (list attached).

Candy Hente, Farmington Regional Chamber, addressed the Council to provide an update on the Farmington Regional Chamber.

Reports were given by Committee Chairs with discussion.

Councilor Follis made a motion to declare items as surplus property (list attached) [with the intentions of donating the four Crown Victoria cages to St. Francois County], seconded by Councilor Linnenbringer, and passed unanimously.

Greg Beavers, City Administrator, provided an update and answered questions from the Council.

Councilor Linnenbringer made a motion to approve the consent agenda, seconded by Councilor Morrison, and passed unanimously.

BILL 09012021-ORDINANCE 6-162: AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, BY AMENDING TITLE III: TRAFFIC CODE, SCHEDULE II. STOP AND YIELD INTERSECTIONS. BILL 10012021: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, SECTION 110.170 REGULAR MEETINGS OF THE CITY COUNCIL.

Councilor Follis made a motion for the first reading by title only of Bill 11012021, seconded by Councilor Linnenbringer, and passed unanimously.

Counselor Reid read the following Bill once by title only.

BILL 11012021: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON CHAPTER 320: SPEED REGULATIONS BY ADDING A NEW SECTION RELATED TO WORK AND CONSTRUCTION ZONES.

Mayor Forsythe discussed installing a crosswalk in front of the Friends in Action Clubhouse on Walton Drive.

Mr. Beavers explained what is needed in order to have a crosswalk at this location.

Larry Lacy, Public Works Director, explained ideas that have been discussed in the past and Walmart's decision on having sidewalk access through the back of their property to the Maple Valley area.

Councilor Follis made a motion to adjourn to closed session to discuss matters pursuant to real estate as authorized by Section 610.021 (2) RSMo, seconded by Councilor Linnenbringer, and passed unanimously.



Councilor Morrison made a motion to adjourn, seconded by Councilor Linnenbringer, and passed unanimously.


