City Council Minutes of Meeting April 8, 2021 6:00 p.m.

The City Council of the City of Farmington met on April 8, 2021, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Kevin Berry gave the invocation.

The roll was called with the following Councilors present: Chad Follis, Harry Peterson, Wayne Linnenbringer, Chris Morrison, Vanessa Pegram, Keli Keutzer and Adam Parks.

City Counselor, Scott Reid, was present.

Officials present were Todd Mecey, Rick Baker, Paula Cartee, Ashley Bischoff, Greg Beavers, Kristen White and Larry Lacy.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Lance and Liz Strickland, 843 Timberline, addressed the Council regarding flooding issues in the storm creek behind their house when it rains. Mrs. Strickland stated that they are losing their backyard to the issue and are looking for a resolution.

Councilor Morrison stated that this issue was talked about in the Public Works Committee meeting and asked Larry Lacy for comment.

Larry Lacy, Public Works Director, addressed the Council to provide his recommendation on the issue.

Councilor Pegram asked if the issue would be fixed if the city fixes the part they are able to.

Mr. Lacy indicated that it would not as part of the issue is due to a bend in the creek.

Mr. Strickland requested the city to also look into the flooding on their street which may be aiding in the issue they are having.
