#### **CITY OF FARMINGTON**

City Council Minutes of Meeting May 13, 2021 6:00 p.m.

The City Council of the City of Farmington met on May 13, 2021, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Kevin Berry gave the invocation.

The roll was called with the following Councilors present: Harry Peterson, Keli Keutzer, David Kennedy, Adam Parks and Chad Follis.

City Counselor, Scott Reid, was present.

Councilor Peterson made a motion to approve the agenda, seconded by Councilor Follis, and passed unanimously.
