City Council Minutes of Meeting May 24, 2021 6:00 p.m.

The City Council of the City of Farmington met on May 24, 2021, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.
