City Council Minutes of Meeting June 10, 2021 6:00 p.m.

The City Council of the City of Farmington met on June 10, 2021, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Murphy Thomas gave the invocation.

The roll was called with the following Councilors present: Harry Peterson, Wayne Linnenbringer, Chris Morrison, Vanessa Pegram, Keli Keutzer, David Kennedy, Adam Parks and Chad Follis.

City Counselor, Scott Reid, was present.

Officials present were Michelle Daniel, Todd Mecey, Tim Porter, Greg Beavers, Travis Trokey, Kristen White, Paula Cartee and Rick Baker.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Candy Hente, Farmington Regional Chamber of Commerce, addressed the Council to thank them for their support of the Country Days event. She explained that she has received great feedback and the event was well attended.

Al Chladek, 619 East College Street, addressed the Council with questions regarding the closing process for the property at 618 Quarry Street. Greg Beavers, City Administrator, explained that he does not know how long it will take but it will have to go through the County.

Nancy Cozean, Highways of History Committee, presented a plaque from the Missouri House of Representatives for the Trail of Tears. She explained that they will have future events and are exploring different financial sources to help with the Trail of Tears video.

Counselor Reid read the following Bill once by title only.
