City Council Minutes of Meeting July 8, 2021 6:00 p.m.

The City Council of the City of Farmington met on July 8, 2021, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Christina Jackson gave the invocation.

The roll was called with the following Councilors present: Wayne Linnenbringer, Chris Morrison, Vanessa Pegram, David Kennedy, Adam Parks and Chad Follis.

City Counselor, Scott Reid, was absent.

Officials present were Greg Beavers, Tim Porter, Michelle Daniel, Todd Mecey, Paula Cartee, Larry Lacy, and Kristen White.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Paul Bickford, 7320 Hall Street, St. Louis, Missouri, addressed the Council on behalf of Waste Management to apologize for service delays in the area, explain that the company has been impacted by a driver shortage and that pickups should now be within 24 hours of originally scheduled pickup dates.
