City Council Minutes of Meeting September 27, 2021 6:00 p.m.

The City Council of the City of Farmington met on September 27, 2021, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Wayne Linnenbringer gave the invocation.

The roll was called with the following Councilors present: Harry Peterson, Wayne Linnenbringer, Chris Morrison, Keli Keutzer, Adam Parks, and Chad Follis.

City Counselor, Scott Reid, was present.

Officials present were Greg Beavers, Tim Porter, Todd Mecey, Travis Trokey, Larry Lacy, Rick Baker, Paula Cartee and Kristen White.

Councilor Linnenbringer made a motion to approve the agenda, seconded by Councilor Follis, and passed unanimously.

Jay Walker, Farmington Family Center, addressed the Council to explain that he has a problem with the homeless on his side of town, it's been getting worse over the last year, one of his barns was burned possibly by a homeless person who was camping on the property, there was an attempted break-in to his office, he has called the police five to six times in recent months regarding issues with the homeless, and he is concerned with the safety of his employees and tenants.

Keli Keutzer questioned if the homeless Mr. Walker has seen have been the same people or different each time. Mr. Walker responded that they have been different people.

Nancy Cozean, 117 Ohio Court, addressed the Council to say thank you for their help with the Bicentennial celebration, she is working on a new project called Highways of Information, and she would like to continue to collaborate with the City and other local communities.

Kevin Berry, 22 Tanglewood Court, addressed the Council regarding his 2021 Farmington Vaccine.

Candy Hente, Farmington Regional Chamber of Commerce, addressed the Council to invite them to two upcoming ribbon cuttings and noted that the State of the City address will be on October 21st.

Reports were given by Committee Chairs with discussion.

Greg Beavers, City Administrator, provided an update, answered questions from the Council, and made a Declaration of Surplus Property - Playground Structure.

Councilor Morrison made a motion to approve the Surplus Playground Structure move from Engler Park to the Lutheran School to be reconditioned and open to the public, seconded by Councilor Linnenbringer, and passed unanimously.

Mayor Forsythe stated that he is looking forward to the State of the City address, offered his condolences to the families of Pete Wiley and Clarion Harrington, and noted that he will be giving a talk about government with the 8th grade class next month.
