J. Roberts asked if there were plans to have more furniture on the Jefferson Street Plaza this summer. Tim Porter, Development Services Director, stated that he would check on this.


J. Williams asked if there was an update on the former Sticky's building that was demolished. Tim Porter, Development Services Director, stated that the lot is privately owned, and he has no update.

ADJOURN


A motion was made (J. Cozean) and seconded (J. Roberts) to adjourn the meeting. The Commission voted unanimously in favor of this motion.
