MINUTES OF PREVIOUS MEETING

A motion was made (N. Cozean) and seconded (D. Lilley) to approve the May 16, 2022 Historic Preservation Meeting Minutes. The Commission voted unanimously in favor of this motion.

NEW BUSINESS

1. Discussion of a Recommendation to City Council for the City Administrator to Apply for Certification as a Trail of Tears Site to Allow for Signage Along Certain Streets and to have the Long House Recognized as a "Witness House" to the Trail of Tears.

Tim Porter, Development Services Director, presented the case to the Commission and stated that the City Administrator needs City Council approval to apply.

Deloris Gray Wood, 6009 South Highway 19, Salem, Missouri, addressed the Commission to explain that she has been working to get the Trail of Tears marked over the last several years, presented a map with changes to the trail, stated that certification should be for the Long House only because the Trail of Tears does not need to be certified, and stated that she would provide an updated sign plan as soon as it is available.

Mary Lee Visnovske, 220 East Harrison Street, addressed the Commission to explain that she is a local business owner, she has a room in her business Earth Mother Health Food honoring

Native Americans, and wants to support anything that can raise awareness about the Trail of Tears.

The Commission discussed the issue. A motion was made (J. Roberts) and seconded (N. Cozean) to send a positive recommendation to City Council for the City Administrator to apply for certification as a Trail of Tears site to allow for signage along certain streets and to have the Long House recognized as a "Witness House" to the Trail of Tears. The Commission voted unanimously in favor of this motion.

2. Application for Historic Sign at 200 West First Street, submitted by Cole Gowen. (Case HP-22-007)

Tim Porter, Development Services Director, presented the case to the Commission.

The Commission discussed the issue. A motion was made (J. Roberts) and seconded (N. Cozean) to deny the application and request submittal of a new design because the current design does not represent the historic character of the downtown area. The Commission voted unanimously in favor of this motion.

Tim Porter, Development Services Director, stated that City Council passed the amendment allowing the Mayor to appoint a non-citizen member to the Historic Preservation Commission.
