CALL TO ORDER

A motion was made (N. Cozean) and seconded (C. Wilson) to add "An Application for Historic Sign at 120 North Washington Street, Submitted by Jason Jent, Jent Insurance Group. (Case HP-22-009)" to the agenda as item number three (3). The Commission voted unanimously in favor of this motion.

A motion was made (N. Cozean) and seconded (D. Lilley) to approve the July 5, 2022 Historic Preservation Meeting Minutes. The Commission voted unanimously in favor of this motion.

1. Discussion of Exterior Murals at Sweetheart Chocolates, 19 South Jackson Street.

Tim Porter, Development Services Director, presented the case to the Commission and stated that no permits were applied for.

The Commission discussed the issue but no action was taken.

2. An Application for Designation as a "Farmington Historical Property" at 206 West Harrison Street, Submitted by Christopher and Jennifer Morrison. (Case HP-22-008)

Tim Porter, Development Services Director, presented the case to the Commission.

Chris Morrison, 604 West Columbia Street, addressed the Commission to explain that he and his wife recently purchased the home and plan to renovate it.

The Commission discussed the issue. A motion was made (D. Lilley) and seconded (N. Cozean) to approve the application to designate the property as historic and forward to the Planning and Zoning Commission. The Commission voted unanimously in favor of this motion.

3. An Application for Historic Sign at 120 North Washington Street, Submitted by Jason Jent, Jent Insurance Group. (Case HP-22-009)

Tim Porter, Development Services Director, presented the case to the Commission.

The Commission discussed the issue. A motion was made (C. Wilson) and seconded (D. Lilley) to approve the application. The Commission voted unanimously in favor of this motion.

Cozean) to send a memorandum to City Council on behalf of the Historic Preservation Commission, stating that improvements to the David Murphy Springhouse are a high priority and consideration should be made to purchase the property. The Commission voted unanimously in favor of this motion.

- D. Lilley stated that Farmington was established 200 years ago this month and suggested contacting the local newspaper to give comments on the anniversary.
