City Council Minutes of Meeting March 10, 2022 6:00 p.m.

The City Council of the City of Farmington met on March 10, 2022, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Wayne Linnenbringer gave the invocation.

Resolution passed unanimously.


Councilor Peterson made a motion for a first reading by title only on Bill 04032022, seconded by Councilor Linnenbringer, and passed unanimously.

Councilor Peterson made a motion to adjourn, seconded by Councilor Linnenbringer, and passed unanimously.


