City Council Minutes of Meeting April 25, 2022 6:00 p.m.

The City Council of the City of Farmington met on April 25, 2022, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Kevin Jenkins gave the invocation.

The roll was called with the following Councilors present: David Kennedy, Adam Parks, Chad Follis, Wayne Linnenbringer, Chris Morrison, Vanessa Pegram and Garrett Boatright.

City Counselor, Scott Reid, was present.

Officials present were Todd Mecey, Tim Porter, Travis Trokey, Larry Lacy, Rick Baker, Ashley Bischoff, Greg Beavers and Paula Cartee.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Kevin Berry, 22 Tanglewood, addressed the Council to share knowledge from the attached handout.

Reports were given by Committee Chairs with discussion.

Chief Todd Mecey provided the 2021 Fire Department Report.

Greg Beavers, City Administrator, provided an update and answered questions from the Council.

Councilor Pegram made a motion to approve the consent agenda, seconded by Councilor Linnenbringer, and passed unanimously.

RESOLUTION R12-2022: A RESOLUTION OF THE CITY OF FARMINGTON, MISSOURI, AUTHORIZING THE MAYOR TO ENTER INTO AND EXECUTE A BIOSOLID LAND APPLICATION AGREEMENT. (GLEN CRAWFORD)

Resolution passed unanimously.

Councilor Pegram made a motion for the reading by title only and Council action on Resolution R13-2022, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Resolution by title only.

RESOLUTION R13-2022: A RESOLUTION OF THE CITY OF FARMINGTON, MISSOURI, APPROVING AND AUTHORIZING THE MAYOR TO ENTER INTO AND EXECUTE THE FOURTH AMENDMENT TO THE DEVELOPMENT AGREEMENT BETWEEN THE CITY OF FARMINGTON AND ROBERT AND NANCY GIERSE. (104 & 106 WEST COLUMBIA)

Councilor Boatright asked Greg Beavers, City Administrator, if the grant amount was still fifty-thousand dollars (\$50,000).

Greg Beavers stated that it was and briefly explained the history of Mr. and Mrs. Gierse's development agreement.

Resolution passed unanimously.


Councilor Pegram made a motion for a second reading by title only and Council action on Bill 05042022, seconded by Councilor Linnenbringer, and passed unanimously.

The roll was called as follows: Councilor Kennedy, aye; Councilor Parks, aye; Councilor Follis, aye; Councilor Linnenbringer, aye; Councilor Morrison, aye; Councilor Pegram, aye; and Councilor Boatright, aye. Seven (7) ayes and no (0) nays, Bill Passed. Councilor Peterson absent and not voting.

Councilor Pegram made a motion to adjourn, seconded by Councilor Linnenbringer, and passed unanimously.
