

# **CITY OF FARMINGTON**

## **City Council Minutes of Meeting September 26, 2022 6:00 p.m.**

The City Council of the City of Farmington met on September 26, 2022, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Kevin Jenkins gave the invocation.

The roll was called with the following Councilors present: Harry Peterson, Wayne Linnenbringer, Chris Morrison, Vanessa Pegram, Adam Parks, and Chad Follis.

City Counselor, Scott Reid, was present.

Officials present were Larry Lacy, Greg Beavers, Casey Moore, Doug Stotler, Todd Mecey, Tim Porter, Paula Cartee, and Rick Baker.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

The Farmington and Park Hills Lion's Club, and the Play it Forward in the Parkland Fundraising Committee presented checks for the all-inclusive playground.

Kevin Berry, 22 Tanglewood, addressed the Council regarding a handout that he shared.

Reports were given by Committee Chairs with discussion.


Mayor Forsythe addressed the issue of mowing the right-of-way along the highway.
