PUBLIC WORKS
MINUTES OF MEETING

The Public Works Committee of the City of Farmington met in regular session on August 11, 2022 at the Development Services Building, 12 South Franklin Street, Farmington, Missouri, 63640.

At 5:00pm, W. Linnenbringer called the meeting to order.

The roll was called with the following members present: Chad Follis – present; Wayne Linnebringer – present; Adam Parks – present; Garrett Boatright – absent (arrived later).

Guests present were: Larry Lacy and Kristen White.

ADDITIONS AND DELETIONS TO AGENDA

L. Lacy stated that Old Business item number two (2) and New Business item number three (3) need to be deleted. A. Parks motioned to approve the deletions, seconded by C. Follis. The Committee voted unanimously in favor of this motion.

MINUTES OF PREVIOUS MEETING

A. Parks motioned to approve the July 14, 2022 meeting minutes, seconded by C. Follis. The Committee voted unanimously in favor of this motion.

OLD BUSINESS

1. Lindsey Theobald at 4146 2nd St., Delassus, Connect to City Water – L. Lacy stated that he spoke with a representative from SRG and will report back with any updates.
2. Cost Sharing for Extending Kiesha Lane Outside Buckhaven Subdivision (Revisit) - Deleted

NEW BUSINESS

1. 710 Barefield Court, Sewer Concern – Shawn Brumfield, 710 Barefield Court, addressed the Committee to explain that the sewer backed up into his basement after the last hard rain, at least one other neighbor on his street also had sewer backup on the same day, the stopper valve in his home has failed twice, there is no backup generator at the lift station, and he would like to know what can be done to fix the issue.

L. Lacy suggested that Mr. Brumfield install a grinder pump and use plugs. He also stated that the City will inspect the area to see if there are any leaks that were not caught during recent smoke testing, and he is looking into purchasing a generator for the lift station.

The Committee discussed the issue, but no action was taken.

2. Retuning City Farm to Posted Hours – The Committee discussed the issue.

G. Boatright made a motion to go back to posted hours for a four (4) week period beginning on August 22, 2022, seconded by C. Follis. The Committee voted unanimously in favor of this motion.

G. Boatright made a motion to send a favorable recommendation to Public Safety to install cameras as the City Farm, seconded by C. Follis. The Committee voted unanimously in favor of this motion.

3. Flat River Road Overlay - Deleted

4. Weber Road Reduction of Scope – L. Lacy stated that he has not yet received completed plans from Taylor Engineering and suggested leaving two (2) lanes with a curb and sidewalk on the south side and adding a storm pipe so work can begin in November 2022. The Committee discussed the issue. G. Boatright motioned to approve the reduction of scope, seconded by C. Follis. The Committee voted unanimously in favor of the motion.

5. Discussion of Extending Power to Possible New Subdivisions at the Edge of the City Limits – The Committee discussed the issue, but no action was taken.

6. Old Fredericktown Road Intersection Proposed Improvements – The Committee discussed the issue, but no action was taken.


7. Accepting Maintenance of Keisha Lane (Start the 1-Year Period)– L. Lacy stated that Steve Johns has asked the City to start the one (1) year clock to accept maintenance. The Committee discussed the issue. C. Follis motioned to start the one (1) year waiting period to accept maintenance of Keisha Lane, seconded by A. Parks. The Committee voted unanimously in favor of this motion.

8. End of 90-Day Trial for Stop Sign at Maple Hills Drive & Bray Road – The Committee discussed the issue. C. Follis motioned to make the stop sign permanent, seconded by A. Parks. The Committee voted unanimously in favor of this motion.

9. Other Items – None.

ADJOURN

G. Boatright motioned to adjourn the meeting, seconded by A. Parks. The Committee voted unanimously in favor of the motion.
