PUBLIC WORKS
MINUTES OF MEETING

The Public Works Committee of the City of Farmington met in regular session on September 8, 2022 at the Development Services Building, 12 South Franklin Street, Farmington, Missouri, 63640.

At 5:04pm, W. Linnenbringer called the meeting to order.

The roll was called with the following members present: Wayne Linnebringer – present; Adam Parks – present; Garrett Boatright – present, Chad Follis – absent (arrived later).

Guests present were: Larry Lacy, Greg Beavers, and Kristen White.

ADDITIONS AND DELETIONS TO AGENDA

L. Lacy stated that “Weber Road Improvements” needs to be added to Old Business. G. Boatright stated that “Sidewalk on the 300 Block of South Main, Near Overton & Warren”, needs to be added to New Business. G. Boatright made a motion to approve the additions, seconded by A. Parks. The Committee voted unanimously in favor of this motion.

MINUTES OF PREVIOUS MEETING

A. Parks motioned to approve the August 11, 2022 meeting minutes, seconded by G. Boatright. The Committee voted unanimously in favor of this motion.

OLD BUSINESS

1. Cost Sharing for Extending Kiesha Lane Outside Buckhaven Subdivision (Revisit) – L. Lacy stated that the request was made in July of 2021 and the estimate approved by the Public Works Committee at that time was \$3040.00. A check was never issued, but Tom Fahnstock provided an invoice for \$3820.00.

G. Boatright made a motion to approve cost sharing for extending Kiesha Lane, seconded by C. Follis. The Committee voted unanimously in favor of this motion.

2. 710 Barefield Court, Sewer Concern – Camera Results – The Committee discussed the issue but no action was taken.
3. Weber Road Improvements – L. Lacy stated that a public meeting was held on September 9, 2022 regarding improvements.


G. Boatright made a motion send the proposed changes to the Public Safety Committee for review, seconded by C. Follis. The Committee voted unanimously in favor of this motion.

NEW BUSINESS

1. Hwy H Sidewalk Grant Approved – The item was postponed until the next meeting due to time constraints.
2. Angela Hargrove, 215 Hyler Drive, Street Signs/Traffic on Hyler Drive – The item was postponed until the next meeting due to time constraints.
3. Sidewalk on the 300 Block of South Main, Near Overton & Warren – G. Boatright stated that he received a resident complaint regarding the sidewalks in the area that are deteriorating, and access points that are steps and not handicap accessible. L. Lacy stated that his department would work on the area.
4. Other Items – None.
