

# CITY OF FARMINGTON

## City Council Minutes of Meeting February 09, 2023 6:00 p.m.

The City Council of the City of Farmington met on February 09, 2023, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Kevin Jenkins gave the invocation.

The roll was called with the following Councilors present: Harry Peterson, Wayne Linnenbringer, Vanessa Pegram, Garrett Boatright, David Kennedy, Adam Parks, and Chad Follis.

City Counselor, Scott Reid, was present.

Officials present were Greg Beavers, Tim Porter, Todd Mecey, Paula Cartee, Larry Lacy, Casey Moore, Doug Stotler, and Floyd Massey.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Candy Hente, 505 Log Cabin Road, extended an invitation to the Council regarding the State of the County event on February 20, 2023.

Mayor Forsythe asked if the City could reimburse the \$5 attendance fee for any Council members that attend.

Greg Beavers, City Administrator, confirmed that was possible.

Reports were given by Committee Chairs with discussion.

Councilor Linnenbringer made a motion to approve the consent agenda, seconded by Councilor Boatright, and passed unanimously.

Councilor Pegram made a motion for a first reading by title only on Bill 07022023, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.

**BILL 07022023: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, TITLE VII: UTILITIES,**

**CHAPTER 720: ELECTRIC CURRENT DISTRIBUTION SYSTEM, ARTICLE III. CHARGES AND BILLING, - APPROVING AND ADOPTING A RATE INCREASE FOR ELECTRIC CURRENT SUPPLIED BY CITY LIGHT & WATER.**

Councilor Pegram made a motion for a first reading by title only on Bill 08022023, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.

**BILL 08022023: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON BY REPEALING SECTION 710.110: SEWER RATES AND CHARGES AND ADOPTING NEW SEWER USE CHARGES.**

Councilor Pegram made a motion for a first reading by title only on Bill 09022023, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.

**BILL 09022023: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI APPROVING AN AMENDMENT TO THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, TITLE VII: UTILITIES, CHAPTER 705 WATER WORKS SYSTEM, SECTION 705.160 WATER METERS REQUIRED – RATES PRESCRIBED.**

Councilor Pegram made a motion for a first reading by title only on Bill 10022023, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.

**BILL 10022023: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI APPROVING AN AMENDMENT TO THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, TITLE II. PUBLIC HEALTH, SAFETY AND WELFARE BY ADDING A NEW CHAPTER 238 AIRPORT OPERATIONS.**

Councilor Pegram made a motion for a first reading by title only on Bill 11022023, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.

**BILL 11022023: AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, MISSOURI, TITLE IV, SECTION 405.040 AND 405.230, A LAND USE KNOWN AS “ACCESSORY BUILDING AND STRUCTURES, SWIMMING POOLS” AND ENACTING CERTAIN REGULATIONS PERTAINING THERETO.**

Councilor Pegram made a motion for a first reading by title only on Bill 12022023, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.

**BILL 12022023: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI APPROVING AN AMENDMENT TO THE MUNICIPAL CODE OF THE CITY OF**

**FARMINGTON, TITLE IV: LAND USE, CHAPTER 405: ZONING REGULATIONS BY AMENDING THE SECTION RELATED TO MEDICAL MARIJUANA.**

Councilor Pegram made a motion for a first reading by title only on Bill 13022023, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.


**BILL 13022023: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, AUTHORIZING AND DIRECTING THE MAYOR TO DECLARE A DEED RESTRICTION. (PLAY IT FORWARD IN THE PARKLAND)**

Greg Beavers, City Administrator, explained the ordinance.


