City Council Minutes of Meeting February 27, 2023 6:00 p.m.

The City Council of the City of Farmington met on February 27, 2023, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Pro Tempore Morrison.
