City Council Minutes of Meeting March 09, 2023 6:00 p.m.

The City Council of the City of Farmington met on March 09, 2023, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Wayne Linnenbringer gave the invocation.

Mayor Forsythe recused himself from the meeting at 6:05 p.m. due to owning the property referenced in the public hearing.


