Mayor Forsythe stated that a Public Hearing is being held to gain input regarding:

An Application for Rezoning at 501 Memorial Drive. (Case REZ-23-001) The Property is Currently Zoned as "R-3: Residential Single Family" with a proposed zoning of "OP-1: Office and Professional District". Submitted by Chase and Macy Busenbark.

Tim Porter, Director of Development Services, explained the request.

Dave Taylor, 502 Memorial Pl, addressed the Council regarding concerns with bright night lighting, loitering concerns, and decreased property value. Mr. Taylor spoke of a petition last year opposing the rezoning case with Billy Beard at the same property.

Once the City was made aware of the business in a residential area, the City contacted the business owners.

Chase Busenbark, 6548 Busiek Rd, explained his request for rezoning of the property. He stated he is open to a deed restriction for future use of the property.
