

CITY OF FARMINGTON

City Council Minutes of Meeting April 24, 2023 6:00 p.m.

The City Council of the City of Farmington met on April 24, 2023, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Kevin Jenkins gave the invocation.

The roll was called with the following Councilors present: Harry Peterson, Wayne Linnenbringer, Chris Morrison, Garrett Boatright, David Kennedy, and Adam Parks.

Councilor Pegram and Councilor Follis were absent.

City Counselor, Scott Reid, was present.

Officials present were Casey Moore, Greg Beavers, Todd Mecey, Doug Stotler, Chris Bullock, Tim Porter, Floyd Massey, Paula Cartee, and Larry Lacy.

Councilor Boatright made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Candy Hente – 505 Log Cabin Road – Provided a Chamber of Commerce update to the Council regarding Country Days for 2023.

Chris Busenbark – 6548 Busiek Road – Addressed the Council regarding zoning at 501 Memorial Place and stated that he would accept changing the zoning back to residential in the future if needed.

Dave Taylor – 502 Memorial Place – Shared concerns that the future of the property cannot be determined.

Resolution passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.

BILL 18042023 – ORDINANCE 1-658: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, PROVIDING FOR THE ANNEXATION OF TERRITORY TO THE EXISTING CORPORATE BOUNDARIES OF THE CITY OF FARMINGTON, MISSOURI. (1100 SOUTH JEFFERSON STREET) (CASE ANN-23-001)

The roll was called as follows: Councilor Linnenbringer, aye; Councilor Morrison, aye; Councilor Boatright, aye; Councilor Peterson, aye; Councilor Kennedy, aye; and Councilor Parks, aye. Six (6) ayes and no (0) nays, Bill Passed.

BILL 19042023 – ORDINANCE 11-2I 179: AN ORDINANCE AMENDING THE GENERAL ZONING ORDINANCE AND ACCOMPANYING MAP THERETO AND KNOWN AS GENERAL ORDINANCE 11-2I BY CHANGING THE CLASSIFICATION OF THE ZONE DISTRICT FOR CERTAIN PARCELS OF LAND DESCRIBED HEREIN. (501 MEMORIAL DRIVE – CASE REZ-23-001)

The roll was called as follows: Councilor Linnenbringer, nay; Councilor Morrison, nay; Councilor Boatright, aye; Councilor Kennedy, nay; Councilor Peterson, nay, and Councilor Parks, nay. One (1) aye and Five (5) nays, Bill Failed.
