

# **CITY OF FARMINGTON**

## **City Council Minutes of Meeting May 22, 2023 6:00 p.m.**

The City Council of the City of Farmington met on May 22, 2023, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Kevin Jenkins gave the invocation.

The roll was called with the following Councilors present: Wayne Linnenbringer, Chris Morrison, Garrett Boatright, David Kennedy, Adam Parks, Chad Follis, and Harry Peterson.

Councilor Pegram was absent.

City Counselor, Scott Reid, was present.

Officials present were Casey Moore, Greg Beavers, Tim Porter, Chris Bullock, Todd Mecey, Kyle Carter, Doug Stotler, Paula Cartee, Floyd Massey, and Travis Trokey.

Councilor Linnenbringer made a motion to approve the agenda, seconded by Councilor Boatright, and passed unanimously.

Alma Lorch, 117 Oak Hill, from Coldwell Banker Hulsey addressed the Council regarding the rezoning of 918 Weber Road. She spoke in favor of the proposed use of property. She stated that she feels the development would be an asset to the community.

Christina Jackson, 438 Grand Canyon, addressed the Council regarding the rezoning on Wallace Road. She spoke of keeping neighborhoods traditional and offering low-income housing in other locations. She also expressed concerns regarding the need for sidewalks as the growing homeless population is entering the roadways and almost getting hit.

Reports were given by Committee Chairs with discussion.

Councilor Linnenbringer made a motion to approve the consent agenda, seconded by Councilor Boatright, and passed unanimously.

**RESOLUTION R27-2023: A RESOLUTION OF THE CITY OF FARMINGTON, MISSOURI, AUTHORIZING THE MAYOR TO ENTER INTO AND EXECUTE A MOTOR VEHICLE LEASE WITH THE FARMINGTON TOURISM AND CONVENTION BUREAU FOR A 2008 CHEVROLET IMPALA AND A 2009 CHEVROLET IMPALA.**

Resolution passed unanimously.

Councilor Boatright made a motion for a first and second reading by title only and Council action on Bill 25052023, seconded by Councilor Linnenbringer, and passed unanimously.


Scott Reid, City Counselor, read the following Bill twice by title only.
