City Council Minutes of Meeting August 28, 2023 6:00 p.m.

The City Council of the City of Farmington met on August 28, 2023, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Kevin Jenkins gave the invocation.

The roll was called with the following Councilors present: Garrett Boatright, Adam Parks, Chad Follis, Harry Peterson, Wayne Linnenbringer, Chris Morrison, and Vanessa Pegram.

Councilor Kennedy was absent.

City Counselor, Scott Reid, was present.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Candy Hente, 505 Log Cabin Rd, provided the Council with a Chamber of Commerce update.

Reports were given by Committee Chairs with discussion.

Councilor Pegram gave the update for Administrative Services.

Councilor Pegram made a motion to approve the consent agenda, seconded by Councilor Linnenbringer, and passed unanimously.

RESOLUTION R43-2023: A RESOLUTION OF THE CITY OF FARMINGTON, MISSOURI, AMENDING RESOLUTION R41-2023, AUTHORIZING THE CITY ADMINISTRATOR TO APPLY FOR FUNDING THROUGH THE MISSOURI DEPARTMENT OF TRANSPORTATION, TRANSPORTATION ALTERNATIVES PROGRAM GRANT FOR

CONSTRUCTION OF A SIDEWALK ON THE HIGHWAY H FROM OLD FREDERICKTOWN ROAD TO AVERY APARTMENTS (FORMERLY ICON APARTMENTS).

Resolution passed unanimously.

RESOLUTION R44-2023: A RESOLUTION OF THE CITY OF FARMINGTON, MISSOURI, AUTHORIZING THE MAYOR TO ENTER INTO AND EXECUTE AN AGREEMENT WITH THE MINERAL AREA DRUG TASK FORCE (MADTF) FOR THE ASSIGNMENT OF OFFICER DANIEL HALEK.

Resolution passed unanimously.

BILL 34082023 – ORDINANCE 1-661: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, TO ESTABLISH A PROCEDURE TO DISCLOSE POTENTIAL CONFLICTS OF INTEREST AND SUBSTANTIAL INTERESTS FOR CERTAIN MUNICIPAL OFFICIALS.
