

CITY OF FARMINGTON

City Council Minutes of Meeting November 27, 2023 6:00 p.m.

The City Council of the City of Farmington met on November 27, 2023, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Mayor Forsythe held a moment of silence for the passing of Kenny Moran and Bruce Boren.

Wayne Linnenbringer gave the invocation.

The roll was called with the following Councilors present: Chad Follis, Harry Peterson, Wayne Linnenbringer, Chris Morrison, Garret Boatright, and David Kennedy.

Councilor Parks and Councilor Pegram were absent.

City Counselor, Scott Reid, was present.

Councilor Boatright made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.
