City Council Minutes of Meeting December 14, 2023 6:00 p.m.

The City Council of the City of Farmington met on December 14, 2023, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Wayne Linnenbringer gave the invocation.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Candy Hente, 505 Log Cabin Road, provided a Chamber of Commerce update.

Reports were given by Committee Chairs with discussion.

Councilor Morrison made a motion to approve the hiring of Police Officers, seconded by Councilor Pegram, and passed unanimously.

BILL 50122023: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, GRANTING A SPECIAL USE PERMIT AT 1521 TOWER AVENUE TO ALLOW FOR A RADIO COMMUNICATIONS TOWER IN AN I-1: GENERAL INDUSTRIAL DISTRICT. (CASE SUP-23-002)

Councilor Boatright made a motion for a first reading by title only on Bill 51122023, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.

BILL 51122023: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, GRANTING APPROVAL TO CARL PETERSON FOR AN AMENDMENT TO THE LANGUAGE OF A PLAT OF A PLANNED UNIT DEVELOPMENT AT 201 MAPLE VALLEY DRIVE. (PUD-23-003)

Councilor Boatright made a motion for a first reading by title only on Bill 52122023, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.

BILL 52122023: AN ORDINANCE AMENDING THE GENERAL ZONING ORDINANCE AND ACCOMPANYING MAP THERETO AND KNOWN AS GENERAL ORDINANCE 11-2I BY CHANGING THE CLASSIFICATION OF THE ZONE DISTRICT FOR CERTAIN PARCELS OF LAND DESCRIBED HEREIN. (1647 DOUBET ROAD – CASE REZ-23-009)

Councilor Boatright made a motion for a first reading by title only on Bill 53122023, seconded by Councilor Linnenbringer, and passed unanimously.

Scott Reid, City Counselor, read the following Bill once by title only.

BILL 53122023: AN ORDINANCE OF THE CITY OF FARMINGTON MISSOURI AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, TITLE II: PUBLIC HEALTH SAFETY AND WELFARE BY ADDING A NEW TITLE XV – ORDINANCE VIOLATIONS REGARDING CAMPING IN PUBLIC PLACES.


