1. An Application to Construct a Carport at 201 West Columbia Street (Case HP-23-003), submitted by Farmington Christian Church.

Scott Rich, Farmington Christian Church, addressed the Commission to explain that he was attending the meeting on behalf of Mark Dotson, presented a sketch of the proposed carport, stated that the church would like to pour a thirteen by thirty-six foot concrete pad on the back part of the lot, and construct a carport with a gabled roof that would match the color of the stone on the church.

The Commission discussed the issue but no action was taken.

Mr. Rich stated that there is an upcoming church board meeting, and he will present alternatives that were discussed today and bring a new design back to the Historic Preservation Commission at the next meeting.

2. An Application for a Sign at 3 North Henry Street (Case HP-23-004), submitted by Signs Etc.

Tim Porter, Development Services Director, presented the case to the Commission.

The Commission discussed the issue. A motion was made (D. Lilley) and seconded (J. Roberts) to approve the application for a sign. The Commission voted unanimously in favor of this motion.

J. Williams stated that work is being done on the front porch of the Long House that should be completed before Country Days, and there are plans to give tours during the event.


### **OTHER NON-AGENDA TOPICS**

T. Porter stated that a property owner on West Columbia Street has expressed interest in a residential historic district and explained the process required for approval.


