CALL TO ORDER

ADDITIONS AND DELETIONS TO AGENDA

A motion was made (S. Slinkard) and seconded (C. Wilson) to delete item number four (4) and add nomination of chairperson and vice chairperson. The Commission voted unanimously in favor of this motion.

1. An Application for Signage and Exterior Paint at 104 West Harrison Street (Case HP-23-008), submitted by the City of Farmington.

Tim Porter, Development Services Director, stated that the City of Farmington Development Services and Utility offices will be located in the building, and the paint colors will be close to the existing color.

The Commission discussed the issue. A motion was made (W. Linnenbringer) and seconded (D. Lilley) to approve the exterior design plan. The Commission voted unanimously in favor of this motion.

2. An Application for a Sign at 108 West Columbia Street (Case HP-23-009), submitted by Signs Etc.

Tim Porter, Development Services Director, stated that this will be a four-by-four wall sign.

The Commission discussed the issue. A motion was made (C. Wilson) and seconded (S. Slinkard) to approve the sign. The Commission voted unanimously in favor of this motion.

3. An Application for Exterior Signs at 225 East Columbia Street (Case HP-23-010), submitted by Signs Etc.

Tim Porter, Development Services Director, stated that this is for the First State Financial Management building.

The Commission discussed the issue. A motion was made (D. Lilley) and seconded (S. Slinkard) to approve the signs. The Commission voted unanimously in favor of this motion.

4. Nominations for Historic Preservation Chairperson and Vice Chairperson.

A motion was made (C. Wilson) and seconded (S. Slinkard) to nominate Jessie Williams as Chairperson of the Historic Preservation Commission. The Commission voted unanimously in favor of this motion.

A motion was made (J. Williams) and seconded (S. Slinkard) to nominate Carla Wilson as Vice Chairperson of the Historic Preservation Commission. The Commission voted unanimously in favor of this motion.


