PUBLIC WORKS MINUTES OF MEETING

The Public Works Committee of the City of Farmington met in regular session on June 8, 2023 at the Development Services Building, 12 South Franklin Street, Farmington, Missouri, 63640.

At 5:01pm, H. Peterson called the meeting to order.

The roll was called with the following members present: Wayne Linnenbringer – present; Chris Morrison – absent (arrived later); Harry Peterson – present; Chad Follis – present.

Guests present were: Larry Lacy, Kristen White, and Mayor Forsythe.

ADDITIONS AND DELETIONS TO AGENDA

W. Linnenbringer motioned to add Report on New Aeration System at East Treatment Plant Cost Savings to the agenda, seconded by C. Follis. The Committee voted unanimously in favor of this motion.

MINUTES OF PREVIOUS MEETING

C. Follis motioned to approve the May 11, 2023 meeting minutes, seconded by W. Linnenbringer. The Committee voted unanimously in favor of this motion.

OLD BUSINESS

- 1. Infrastructure Cost to Provide Power to New Developments
 - L. Lacy stated that he had no updates.
- 2. Discussion of the City Taking Over Maintenance of the Private Streets within Greenbrian Estates, submitted by Lori Sloup (829 Pinehurst Drive).
 - L. Lacy stated that he had no updates.

Lori Sloup, 829 Pinehurst Drive, addressed the Committee to explain that she spoke with the president of the homeowner's association, and he plans to update the neighborhood once a plan is in place.

The Committee discussed the issue, but no action was taken.

- 3. Citizen Input on the Extension of Industrial Drive
 - L. Lacy stated that he had no updates.

Amanda Farrell, 520 Maple Street, addressed the Committee to explain that Industrial Drive is too narrow for the amount of traffic and large vehicles on the road.

- 4. Industrial Pretreatment Program 101
 - L. Lacy presented a report on the Farmington Pretreatment Program.

The Committee discussed the issue, but no action was taken.

NEW BUSINESS

- 1. Section 710.073 Extra Strength Discharge Proposed Change
 - L. Lacy stated that the fine for industry giving extra strength discharge has not been updated since 1992, the cost has gone up approximately four-fold, and he is proposing a four-fold increase.
 - H. Peterson asked if this would apply to current fines. L. Lacy replied that it would not.

The Committee discussed the issue. C. Follis motioned to approve the proposed changes, seconded by W. Linnenbringer. The Committee voted unanimously in favor of this motion.

- 2. Revisit if drainage issue behind Timberline Drive (mentioned during the May meeting)
 - L. Lacy stated that water runs off the west side of the park in the area and gets concentrated near several homes, a ditch could be used to control the water, and the cost of the materials and labor is minor.

The Committee discussed the issue. C. Morrison motioned to extend the storm system east from Timberline Drive to the existing park property between 850 & 842 Timberline Drive, with a collection ditch on the park property, seconded by H. Peterson. The Committee voted unanimously in favor of this motion.

- 3. Discussion of Swimming Pool Water Rate Discounts
 - L. Lacy stated that this was a citizen request to not pay sewer rates when filling a pool, and the same request has been denied in the past.
 - C. Morrison requested cost estimates to further evaluate.

The Committee discussed the issue, but no action was taken.

- Stop Sign Request at Autumn Chase & Black Rock Lane, Cripple Creek Lane & Black Rock Lane, Cripple Creek Lane & Autumn Chase, and Black Rock Lane & Autumn Chase
 - L. Lacy stated that in his opinion, this is excessive for this subdivision.

The Committee discussed the issue. C. Morrison motioned to send the request for the stop sign at Autumn Chase & Southbound Black Rock Lane to Public Safety and deny the request for Cripple Creek Lane & Black Rock Lane, Cripple Creek Lane & Autumn Chase, and Black Rock Lane & Autumn Chase, seconded by H. Peterson. The Committee voted unanimously in favor of this motion.

- 5. Four-Way Stop Request at Alexander Avenue & West Liberty Street, submitted by Lesley Hughes
 - L. Lacy stated that a resident made this request for speed control, this is not a square intersection, and it would take time for vehicles to clear the intersection if it were a four-way stop.
 - C. Morrison asked if traffic control measures could be put in place. L. Lacy replied that enforcement would be an option.

The Committee discussed the issue. C. Morrison motioned to deny the request, seconded by C. Follis. The Committee voted unanimously in favor of this motion.

6. Amanda Farrell Email

Amanda Farrell, 520 Maple Street, addressed the Committee to explain that Maple Street between Potosi Street and A Street gets a lot of foot traffic, there is not a continuous sidewalk in the area, and she would like to see a sidewalk from Center Street to Potosi Street on Maple Street.

L. Lacy stated that he would provide a cost estimate of the work at the next meeting.

The Committee discussed the issue, but no action was taken.

7. New Aeration System at East Treatment Plant Cost Savings

The Committee did not discuss the issue due to time constraints.

ADJOURN

H. Peterson motioned to adjourn the meeting, seconded by C. Follis. The Committee voted unanimously in favor of the motion.
