City Council Minutes of Meeting March 25, 2024 6:00 p.m.

Scott Reid, City Counselor, read the following Bill once by title only.

BILL 10032024 – ORDINANCE 12-798: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, BY AMENDING CHAPTER 426 DESIGN STANDARDS FOR PUBLIC WORKS IMPROVEMENTS BY AMENDING THE LANGUAGE RELATING TO TURNAROUND PROVISIONS ON CITY STREETS.
