City Council Minutes of Meeting October 10, 2024 6:00 p.m.

The City Council of the City of Farmington met on October 10, 2024, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Mayor Forsythe held a moment of silence for retired Farmington Fire Captain Alan Thomure.

Scott Reid, City Counselor, read the following Bill once by title only.

BILL 45092024 – ORDINANCE 4-59: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, PROHIBITING THE SALE OF HEMP SYNTHESIZED INTOXICANTS.

John Krause, Safety Officer with the Farmington R7 School District, addressed the Council regarding the impact of cannabis on children, and spoke in support of the ordinance on behalf of the School District.

The roll was called as follows: Councilor Linnenbringer, aye; Councilor Morrison, aye; Councilor Combs, aye; Councilor Pegram, aye; Councilor Kennedy, aye; Councilor Follis, aye; and Councilor Peterson, aye. Seven (7) ayes and no (0) nays, Bill Passed.

Mayor Forsythe shared information on upcoming events taking place at Long Memorial Hall throughout October. He also announced Kristen White with the Tourism Bureau will present information on the recent Blues, Brews & BBQ event at the next Council meeting on October 28, 2024.
