Mayor Forsythe stated that a Public Hearing is being held to gain input regarding:

An Application for a Special Use Permit to install ground mounted solar panels at 530 John David Dr. (Case SUP-24-0001) The property is currently zoned as "R-2" Single-Family Residential Districts." Submitted by Casa Del Solar on behalf of Ron Neighbor.

Greg Beavers, City Administrator, explained the request, stating that the ground installation would include an eight-panel solar panel system.

David Jirik, 531 James Court, spoke in opposition of the Special Use Permit. He shared concerns regarding the appearance of the solar panel structures, and the enforcement of regulations on the structures, stating that other city ordinances involving grass clippings and animal waste are not regularly enforced.

Councilor Linnenbringer asked if the solar panels could be installed on the roof of the home.

The solar company replied that they only work with ground installation, and the homeowner has a light-colored roof to help control temperature in the home. He stated roof mounted solar panels will raise the temperature of the home and create potential leaking issues.
