

CITY OF FARMINGTON

City Council Minutes of Meeting December 12, 2024 6:00 p.m.

The City Council of the City of Farmington met on December 12, 2024, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Mayor Forsythe read the obituaries for former City Council members Bill Matthews and Mark Kellogg, and held a moment of silence for Bill Matthews, Mark Kellogg, Frank Taylor, and Gary Busenbark.

Wayne Linnenbringer gave the invocation.

The roll was called with the following Councilors present: Dan Combs, Vanessa Pegram, Chad Follis, Harry Peterson, Wayne Linnenbringer, and Chris Morrison.

Councilor Kennedy and Councilor Parks were absent.

Officials present were Larry Lacy, Tim Porter, Kyle Carter, Casey Moore, Chris Bullock, and Paula Cartee.

City Counselor, Scott Reid, entered the meeting at 6:12 p.m.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Kevin Berry, 22 Tanglewood, proposed a new slogan for the City of Farmington. (See attached letter provided to the Council)

Reports were given by Committee Chairs with discussion.

Councilor Linnenbringer made a motion to purchase 24 CF-33 Tough Books, docking stations, and keyboards for a total cost of \$131,443.20 minus the ARDA Grant for \$20,000, the Highway Safety Grant for \$17,979, and the City's fifty-fifty matching ARPA Grant for \$20,000, bringing the total cost to \$73,464.20, seconded by Councilor Pegram, and passed unanimously.

Mayor Forsythe appointed Councilor Follis to fill Councilor Harry Peterson's unexpired term on the Public Works Committee.

Councilor Pegram made a motion to cancel the December 23, 2024 Council and Public Services Committee meeting, seconded by Councilor Linnenbringer, and passed unanimously.

Councilor Pegram requested Council members attend the December 16, 2024 Administrative Services Committee meeting to discuss Lagers benefit information.

Councilor Linnenbringer made a motion to approve the consent agenda, seconded by Councilor Pegram, and passed unanimously.
