PUBLIC WORKS MINUTES OF MEETING

The Public Works Committee of the City of Farmington met in regular session on March 14, 2024 at the Development Services Building, 101 South Jefferson Street, Farmington, Missouri, 63640.

At 4:35pm, H. Peterson called the meeting to order.

The roll was called with the following members present: Wayne Linnenbringer – absent; Chris Morrison – present; Harry Peterson – present; Chad Follis – present.

Guests present were: Larry Lacy, Tim Porter, Charity Comstock, and Greg Beavers.

ADDITIONS AND DELETIONS TO AGENDA

H. Peterson motioned to delete items one and two from old business, seconded by C. Follis. The Committee voted unanimously in favor of this motion.

MINUTES OF PREVIOUS MEETING

C. Morrison made a motion to approve the January 11th, 2024 meeting minutes, seconded by C. Follis. The Committee voted unanimously in favor of this motion.

NEW BUSINESS

- 1. Change Order for Pole Replacement Project
 - L. Lacy stated there is \$200,000. In the budget for this year and have issued bids for two projects, one has been complete. L. Lacy requests a second change order of \$15,800 to complete the project.

The Committee discussed the issue, H. Peterson motioned to approve the \$15,800 change order for the Pole Replacement and PLC Contract, seconded by C. Morrison. The Committee voted unanimously in favor of this motion.

- 2. City Farm: Possibly manning the facility during posted hours and closing it otherwise.
 - C. Morrison stated adding cameras on the property would be beneficial. The Committee decided unanimously to revise a plan and revisit this item. No action was taken.
- 3. Possible Revision to ST-3 (12" gutter pan vs. 24" gutter pan) www.farmington-mo.gov

The Committee discussed the pros and cons. L. Lacy stated the asphalt will be more cost efficient and aid in traffic safety. He recommended 1ft 6in for local streets and 2ft 6in for all others. L. Lacy stated there would be revisions to design standards and standard specifications as a package. No motions were made, or votes taken.

- 4. 2024 Excavation & Hauling Bid- No changes were made.
- 5. 2024 Asphalt Bid- Increased by \$20,000
- 6. 2024 Concrete Bid No changes were made.
- 7. Request to Close Korber Road

C. Morrison stated this would be a public safety issue and increase traffic concerns for nearby residents. H. Petterson made a motion to decline the request. W. Linnenbringer seconded the motion.

- 8. Request to move 35 mph speed limit to east city limits on Hwy 32 The Committee discussed the issue, C. Follis motioned to get a second opinion from MODOT, seconded by H. Peterson. The Committee voted unanimously in favor of this motion.
- 9. Water Main Replacement at 32/OO After discussion, The Committee made a unanimous decision to get a survey. No action was taken.
- 10. Burks Road sidewalk request- The Committee discussed the issue; no action was taken.
- 11. Sidewalk request across from the Farmington Middle School- The Committee discussed the issue but no action was taken.
- 12. Design Standards and Project Specification changes- The Committee discussed the issue; no action was taken.
- 13. Request to pave Harrison St. west of A St. L. Lacy stated this has been requested in the past. C. Follis requested more research into this. No action was taken.
- 14. Other Items- None
