City Council Minutes of Meeting January 27, 2025 6:00 p.m.

The City Council of the City of Farmington met on January 27, 2025, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Scott Reid, City Counselor, read the following Resolution by title only.


