City Council Minutes of Meeting March 24, 2025 6:00 p.m.

The City Council of the City of Farmington met on March 24, 2025, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Forsythe.

Wayne Linnenbringer gave the invocation.

RESOLUTION R17-2025: A RESOLUTION OF THE CITY OF FARMINGTON, MISSOURI, AUTHORIZING THE MAYOR TO ENTER INTO AND EXECUTE A THIRD AMENDMENT TO THE CONTRACT WITH BROCKMILLER INC. (CONSTRUCTION MANAGER AT-RISK)
