City Council Minutes of Meeting June 23, 2025 6:00 p.m.

The City Council of the City of Farmington met on June 23, 2025, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Morrison.

Wayne Linnenbringer gave the invocation.

The roll was called with the following Councilors present: Wayne Linnenbringer, Joshua Smith, Dan Combs, Vanessa Pegram, David Kennedy, Adam Parks, and Chad Follis.

Councilor Kauflin arrived at 6:13 pm.

Officials present were Floyd Massey, Casey Moore, Greg Beavers, Kyle Carter, Paula Cartee, and Tim Porter.

City Counselor, Scott Reid, was present.

Councilor Pegram made a motion to approve the agenda, seconded by Councilor Linnenbringer, and passed unanimously.

Acey Walker, 623 W. Columbia, addressed the Council with concerns regarding the safety of mosquito fogging, stating that any employee spraying the chemicals must be certified and the money could be better spent on community greenhouses and gardens.

Nika Turner, 241 E. Hillside Dr, stated that No Fog Farmington will continue working towards bat boxes, purple martin boxes, and educational events.

Jim Harris, 341 Kenwood, shared concerns with the Council over health issues from mosquito spraying and stated that the cost saved from not spraying could go towards other mosquito control options like bat and purple martin boxes.

Reports were given by Committee Chairs with discussion.

Councilor Pegram made a motion to postpone Bill 14042025 to July 10, 2025 Council meeting, seconded by Councilor Linnenbringer, and passed unanimously.
