City Council Minutes of Meeting October 9, 2025 6:00 p.m.

The City Council of the City of Farmington met on October 9, 2025, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri 63640.

The meeting was called to order by Mayor Morrison.

Wayne Linnenbringer gave the invocation.

Candy Hente, 202 North Washington St, gave a Chamber of Commerce update, and thanked Mayor Morrison and the City for hosting the Lead Local Leadership Program and providing educational opportunities for the participants.

Julie Forthman, 800 East Liberty St, shared safety concerns regarding the proposed roundabout at Bray Road and the ability of the community to navigate the roundabout at first. She also asked where to go for volunteering opportunities.
