The City Council of the City of Farmington met on June 13, 2019 at Long Memorial Hall. The hearing was called to order by Mayor Forsythe.

Mayor Forsythe stated that a Public Hearing is being held to gain input regarding an:

Amendment to the Municipal Code of the City of Farmington, Title IV: Land Use, Chapter 405: Zoning Regulations by adding a new section related to Medical Marijuana.

Tim Porter, Director of Development Services, explained the proposed amendment.

Councilor Joyce questioned what the expectations were for the locations of dispensaries and growing facilities.

Tim Porter explained the zoning districts and where these places may go.

Councilor Pegram asked if the dispensaries had to have a special permit to be in a C-3 Zoning District.

Tim Porter responded that dispensaries would need a Special Use Permit in a C-3 zone if this Ordinance passed.

Councilor Linnenbringer mentioned the banking issues that these types of businesses might have.

Greg Beavers, City Administrator, explained the banking issues they may face because of Federal Laws.

Mayor Forsythe asked if the requirements could be changed in the future.

Greg Beavers explained that they could not set unreasonably restrictive rules or more than a 1,000-ft. buffer.

Scott Reid, City Attorney, mentioned that changes in the future could result in a prior nonconforming use for businesses operating before the change.

At 7:14 p.m., Mayor Forsythe asked for a motion to reopen the Public Hearing on Medical Marijuana for public comment. Councilor Joyce made a motion, seconded by Councilor Pegram, and passed unanimously.

Mayor Forsythe asked if anyone from the public or Council would like to comment on the Medical Marijuana issue.

Councilor Pegram questioned the hours of operation for these facilities.

Greg Beavers mentioned that restricting the hours of operation could be challenged as limiting access to people coming from out of town.

Councilor Joyce shared that there is still a stigma and some people do not want to be seen buying their products.
