Larry Lacy, Public Works Director, explained the request.


Tim Porter, Development Services Director, stated that the Planning & Zoning Committee made a favorable recommendation on the matter.

Councilor Pegram asked if we wanted to delete it or change it.


Councilor Boatright explained how Planning & Zoning felt about the matter.






Mayor Forsythe stated that a Public Hearing is being held to gain input regarding:
