Aggravated Robbery Suspect Arrested

Just after 9pm on October 14, 2013 a robbery was reported at Papa Johns Pizza, 6725 Dick Flynn Blvd. Officers McFarland and Collier responded to the scene and learned that a masked man with a box cutter entered the store demanding money. During the confrontation, a teenage employee received a minor cut from the suspect's box knife. The suspect fled on foot towards State Route 28.

Officer Bucksath responded from home with canine Jynx

and attempted a track, however the suspect could not be located.

In the days and weeks that followed, Sergeant Robinson and Officer McFarland followed up on potential leads until one lead them to Eric Robbins, 23, of Loveland. Robbins confessed to the robbery, telling officers that he was both drunk and under the influence of pills. Robbins was taken to jail and charged with Aggravated Robbery.

Burglars Apprehended after Foot Chase

On December 6, 2013 at 2am Officer Wulker responded to a Marsh Circle home for a burglar alarm activation.

When he arrived he heard noises inside and found an entry door into the garage forced open. While awaiting back-up, Officer Wulker observed a suspect that had just jumped out of a second floor window. Upon seeing the officer, the suspect fled on foot. Officer Wulker gave chase and apprehended the 22 year old Goshen man.

The investigation determined that a second man had also been in the house and had fled when Officer Wulker chased the first suspect. The second suspect was identified as a 19 year old Goshen man and he was later apprehended. Both were charged with burglary, drug paraphernalia, and possession of marijuana. At the time of the burglary, the homeowner was out-of-town.

Use of Force and Emergency Driving Training

The Goshen Township Police Department hosted the Ohio Peace Officer Training Academy Driving and Firearms simulators and instructors on September 25-26, 2013. The firearms simulator provided realistic shoot and don't-shoot scenarios ensuring that officers exhibited good judgment in high-stress, fast moving confrontations, some of which warranted the use of deadly force.

The driving simulator focused on officers clearing intersections safely while responding to emergency calls and during traffic pursuits.

All of Goshen's police officers completed this free training, as well as officers from outside departments including, Loveland, Milford, Owensville, Hamilton Township, and Pierce Township.

Some Significant Incidents August 2013—October 2013

On Aug. 20th, Officer McFarland and Sgt. Robinson investigated a burglary that occurred at a home on Garden Drive. A 21 year old acquaintance was identified as the perpetrator and arrested.

On Aug. 20th, a burglary was reported at 1785 State Route 28.

On Aug. 21st, a burglary was reported at 1785 State Route 28.

On Aug. 25th, Sergeant Robinson responded to a Bruce Court home for a report of two teenage brothers under the influence of Psilocybin mushrooms. Upon Sgt. Robinson's arrival, the more violent of the two boys was taken into custody while the other brother exposed his genitals to Robinson. Upon arrival of Miami Township Police Officers to assist, the second boy licked officers while being taken into custody.

On Aug 29th, Captain Rose arrested a 21 year old man for the burglary of a Red Oak Drive home. The suspect is a heroin addict, forced entry, stole a gun and traded the gun for heroin.

On Aug. 30th, Officer's Wolf, West, and Budai responded to a home on Woodville Pike for a domestic involving a 36 year old male armed with a pistol. Upon officers arrival, a woman ran from the home and told them that her boyfriend had taken the gun and their one year old child into a bedroom and locked the door. Officers made entry into the home and after repeated warnings to come out of the room, the man surrendered. The child was unharmed. Charges included, domestic violence, using weapons while intoxicated, & child endangering.

On Sept. 6th, Officer Bucksath investigated the death of a 51 year old female at 1785 State Route 28.

On Sept. 8th, Officer McFarland arrested a 17 year old girl for shoplifting beer from UDF. She was also found to have an open warrant.

On Sept. 8th, a burglary was reported on Barre Road.

On Sept. 9th, a woman was killed in a two car crash at the intersection of Cedarville Road and Goshen Road.

On Sept. 15th, a 56 year old woman overdosed on opiates at a home on Windsor Lane.

On Sept. 15th, Sergeant Robinson investigated an adult male, age 21, from Tennessee, who was soliciting sex and transmitting obscene photographs to a 13 year old boy via social media. The man sent money for the boy to run away to Tennessee for sex. Charges of Importuning and Disseminating Matter Harmful to a Juvenile were filed. The suspect was extradited to Ohio to answer the charges.

On Sept. 16th, Officer Bucksath and Chief Snyder responded to a Cross Creek Drive address for a 54 year old suicidal man armed with a rifle, barricaded inside. The Clermont County Special Response Team (SRT) responded and took him into custody without incident.

On Sept. 19th, Officer Collier arrested a 37 year old woman for OVI and child endangering. The woman was driving under the influence of drugs and had her 14 year old son in the car with her.

On Sept. 19th, a burglary was reported at a home on Redman Drive.

On Sept. 23rd, Chief Snyder investigated a rape that occurred by a known person at an address on Redman Drive.

On Sept. 23rd, Captain Rose investigated an allegation that a 27 year old woman was representing that her 2 year old son has leukemia and a benefit run was about to occur to raise money for this child. The investigation determined that the child is in good health and that the mother was knowingly distributing false information. She was charged with falsification and attempted theft.

On Sept. 27th, a 37 year old man overdosed on opiates at a home on Windsor Lane.

On Sept. 27th, a 29 year old man threw a beer bottle at an employee at Eastgate Lanes and then fled. Officer Wolf initiated a traffic stop and arrested the man for OVI.

On Oct. 1st, a woman was scammed out of \$32,000 by phony sweepstakes documents that she received in the mail. She sent the money to an address in Canada. The United States Secret Service was requested to assist in this case.

On Oct. 2nd, Officer West arrested a 26 year old male and an 18 year old female for shoplifting beer from Kroger. The male was also arrested for an open warrant.

On Oct. 3rd, a 21 year old man overdosed on heroin at a home on Goshen Road.

On Oct. 6th, Officer Collier and Officer McFarland responded to a home on Melody Lane to assist Miami Township Police with a theft investigation. The 26 year old suspect was found hiding under a bed inside the home. Heroin, pills, and paraphernalia were found by officers. The suspect was incarcerated on drug charges and an open warrant.

On Oct. 7th, Sergeant Hampton and Officer Sanders responded to a vacant home on Deerfield Road for a report of squatters living inside. Soon after arrival, a dog charged Sergeant Hampton and Hampton discharged his firearm in self-defense, killing the dog. A 13 year old boy was found inside the home. Childrens Protective Services responded to take emergency custody of the child. The boy's mother was later located and arrested on an outstanding warrant.

On Oct. 7th, Officer Wolf made two arrests following an aggravated burglary at a home on Redman Drive where known suspects, ages 28 and 29, forced their way into the home and assaulted the home owner.

Some Significant Incidents October 2013—December 2013

On Oct. 10th, Captain Rose investigated a car crash on State Route 28 caused by a 23 year old female passenger who intentionally jumped out of the moving car driven by her father. She was charged with disorderly conduct.

On Oct. 11th, Sergeant Hampton investigated a suicide by gunshot. The man was 55 years old and resided at an address on State Route 132.

On Oct. 13th, Officer Wulker arrested a 23 year old woman for shoplifting at Kroger. She was also found in possession of a heroin syringe and was charged with drug abuse instruments.

On Oct. 15th, a 23 year old woman reported a rape on Main Street by a 51 year old male.

On Oct. 16th, Officer Collier arrested a 22 year old woman for shoplifting at Kroger. She was also found in possession of a syringe and was also charged with drug abuse instruments.

On Oct. 19th, a burglary was reported at a home on State Route 48.

On Oct. 21st, Officer Wolf arrested two women ages 46 and 28 for shoplifting at Kroger. The younger of the two was also found to be in possession of narcotic pills and was also charged with drug abuse.

On Oct. 27th, a burglary was reported at a home on Louis Lane.

On Oct. 27th, a 19 year old man died of a drug overdose at 1785 State Route 28. The investigation, led by Sergeant Robinson and Chief Snyder determined that a 22 year old female had assisted the man with the administration of heroin into his body. She has been charged with involuntary manslaughter.

On Oct. 27th, Officer West conducted a routine traffic stop on Snider Road and arrested two men ages 22 & 25 for drug possession, possession of a heroin syringe, and outstanding warrants.

During the overnight hours of Oct. 28th, several unlocked vehicles were entered and stolen from in the Southern Hills subdivision. On Nov. 20th Mason Police conducted a routine traffic stop and recovered a stolen pistol that had been taken from one of the Southern Hills victims.

On Oct. 29th, Officer Bucksath was dispatched for reported drunk driver at 9:30am at Circle K. The vehicle had already struck one vehicle and fled. After fleeing from Bucksath, the 51 year old driver was arrested for OVI, hit-skip, and failure to comply.

On Nov. 1st, Sergeant Robinson began investigating the rapes of two girls ages 12 and 15 by a 14 year old boy. The boy was arrested and charged with two counts of rape and drug trafficking.

On Nov. 1st, a 28 year old man overdosed on opiates at a home in the 2300 block of State Route 28.

On Nov. 1st, a burglary was reported on Angela Court.

On Nov. 5th, Officers Collier, West, and Sgt. Robinson executed a search warrant at an Oakwood Lane address. A large marijuana grow operation was found in the home with young children present. The Clermont County Narcotics Unit was requested and they took over the investigation.

On Nov. 9th, Sergeant Robinson investigated the rape of a 15 year old girl. An 18 year old acquaintance was arrested.

On Nov. 10th, Captain Rose was contacted at home regarding an agitated suicidal man who refused to cooperate with anyone but Rose. Cpt. Rose responded to the man's home and transported him to the hospital for a psych evaluation.

On Nov. 10th, Officer Wulker and Captain Rose responded to a report of a woman tied up and being held in a closet at a home on Cedarville Road.

On Nov. 17th, Officer McFarland investigated a drug overdose involving a 42 year old man at Lakeshore.

On Nov. 18th, a burglary was reported at a home on Short 48.

On Nov. 23rd, Captain Rose took a stolen car report from an address on Oakland Road. The car was crashed and abandoned on Wards Corner Road. On Dec. 11th charges were filed on two 18 year old men from Reading Ohio.

On Nov. 25th, Officer Collier arrested a 51 year old woman for theft of cash and jewelry from family members. The woman acknowledged that she is a heroin addict.

On Nov. 26th, Officer Collier responded to a fight-in-progress at an Angelwood Drive address. Upon arrival, an intoxicated 37 year old man charged him. Officer Collier deployed his taser and took the suspect into custody. Charges included domestic violence and failure to comply.

On Dec. 4th, a burglary was reported on Rhonda Court.

On Dec. 9th, a burglary was reported on Manila Road.

On Dec. 10th, Sergeant Robinson arrested a 36 year old man for three counts of breaking and entering for three different incidents in which the man forced entry into Suburban Propane and stole copper.

On Dec. 11th, Sergeant Robinson and Officer Collier investigated a receiving stolen property offense that occurred in the parking lot of Kroger. A 24 year old female was charged with possession of heroin and child endangering.

On Dec. 17th, Captain Rose and Officer Collier responded to a man down call with a firearm lying beside him at an address on Smith Road. The man was found alive and transported to the hospital for medical and psychological treatment.

On Dec. 19th, Officer Collier assisted by other Goshen Officers prepared and executed a search warrant at a home on Holly Lane. Heroin, cocaine, marijuana, and drug paraphernalia were found. A 33 year old man was arrested.

Automated External Defibrillator (AED) Used to Save Life

On November 14, 2013, Captain Rose responded to a medical emergency involving a man who was experiencing chest pains at a home on Liberty Woods Drive. Just as the Captain arrived, the victim went into cardiac arrest. Rose retrieved the AED carried in the patrol car and connected it to the victim's chest. The machine administered a shock that restarted his heart. EMS arrived shortly thereafter and rushed the man to the hospital.

At a trustees meeting, the victim, Richard Wenzel, presented Captain Rose with a Certificate of Appreciation and he donated money to the CPAAA sponsored, Cops Shopping with Kids Program.

Search Warrant Yields Significant Drugs & Property

During the morning hours of November 1, 2013, a home on Short State Route 48 was burglarized. Entry was made into the home by crawling through a doggy door. Several weeks later a suspect was identified, confessed, and was jailed. The suspect, a heroin addict, provided officers with the location where he traded the stolen property in exchange for heroin.

Officer's West, Moermond, Sergeant Robinson, and members of the Williamsburg Police Department executed a search warrant at the Williamsburg home identified by the suspect. Multiple stolen firearms, stolen tools, a large amount of heroin and drug paraphernalia were found in the home. The Williamsburg homeowner was linked to buying and trading stolen goods for heroin from multiple addicts. Some of the firearms were linked to Brown County burglaries. The investigation continues.

Thefts from Vehicles

In October 2013, Captain Rose initiated an investigation of a loosely organized theft ring involving six adult suspects who have been linked together "Car Hopping," slang that they used for stealing from unlocked vehicles. These individuals did not all work together at one time, rather, there were various connections that developed over time.

These offenses occurred between July-October 2013, always overnight, several nights per week, in pre-planned targeted neighborhoods in Goshen, Union, Pierce, and Anderson Townships. It is estimated among the suspects that hundreds of cars were checked to determine if they were unlocked and upwards of one-hundred

were found unlocked and stolen from. Tens of thousands in merchandise was stolen including credit cards, golf bags, Ipads, sunglasses, CD's, chargers, school bags, wallets, a pistol, two bicycles, and loose change.

The suspects used the credit cards at different Walmart's to purchase primarily pre-paid debit cards and electronics including, Ipads, cell phones, and Xbox video game systems that they would sell on Craigslist as 'brand-new, in the box.'

Alcohol, heroin, and cocaine are contributing factors with some of the suspects. Others described 'Car Hopping' as a treasure hunt that was exciting. The philosophy as expressed by one suspect was, 'If they leave their car unlocked, it's like leaving their valuables in the yard for anyone to take.'

Stolen items were recovered during the execution of a search warrant and other items were handed over by the suspects.

The six suspects have been directly linked to 47 victims. A total of more than \$40,000 in personal property and \$10,000 in credit card transactions were stolen from these 47 victims. Approximately \$17,000 of that stolen property has been recovered during the investigation.

Charges are ongoing in Clermont and Hamilton Counties.

Some Significant Incidents December 2013—February 2014

On Dec. 20th, Sergeant Hampton charged a 14 year old boy with disorderly conduct after the boy shot an airsoft gun at a school bus.

On Dec. 21st, Officer West attempted to stop a vehicle for a traffic violation on State Route 28. The suspect fled in the vehicle and a short pursuit ensued. The suspect drove into a field on Gaynor Road and the suspect fled on foot. Drugs and alcohol were found in the vehicle. The suspect in this case has been returned to prison.

On Dec. 27th, Captain Rose investigated a domestic related stabbing on Twin Oak Lane. A 32 year old man was arrested.

On Dec. 27th, a sexual assault of a 4 year old was reported on Red Oak Dr.

On Dec. 28th, a burglary was reported on Clark Drive.

On Dec. 30th, a 46 year old woman overdosed on opiates on Norma Lane.

On Dec. 30th, a burglary was reported in the 2100 block of State Route 28.

On Dec. 31st, 19 victims from various locations throughout Goshen reported damage to their vehicles and homes caused by a BB gun being shot during the overnight hours. Miami Township also had several similar reports.

On Jan. 1st 2014, Officers Wulker and Wolf investigated a heroin overdose of a 54 year old male at a Mindy Lane home, the man was charged with possession of drug abuse instruments.

On Jan. 1st, Officers Wulker and Wolf responded back to the same Mindy Lane home for a second heroin overdose, this time a 56 year old male. Possession of heroin charges are pending lab results.

On Jan 4th, an 18 year old woman reported a rape that occurred at a Park Avenue home by a known suspect.

On Jan. 7th, forced entry was made into A Music Café during the overnight hours.

During the overnight hours of Jan. 11th, four garages were entered and chainsaws stolen at different homes on Snider Road.

On Jan. 10th, Officers attempted a traffic stop of a suspect wanted in connection with heroin trafficking. The driver fled and a traffic pursuit ensued. The suspect crashed at Bypass 28 near I-275. The suspect was taken into custody and faces many criminal charges including aggravated vehicular assault in addition to drug and fleeing charges.

On Jan. 12th, a 24 year old man overdosed on heroin at a home on Main Street.

On Jan. 13th, Chief Snyder and Captain Rose investigated the death of a 30 year old woman at a home at Country Lake. The woman's death is drug related.

On Jan. 14th, Officer Collier arrested a 31 year old woman for shoplifting from Kroger. It was determined that she was previously banned from Kroger for shoplifting once before. She was also charged with criminal trespass.

During the overnight hours of Jan. 15th, three cars were stolen. One from Belfast Road, another from Rollaway Drive, and the third from 1785 State Route 28.

On Jan. 15th, a Snider Road garage was entered, chainsaws and tools stolen.

On Jan. 17th, a Rollaway Drive garage was forcibly entered.

On Jan. 19th, Captain Rose responded to a domestic violence incident at a Country Lake apartment, when he arrived he found a male bleeding from his wrists and in possession of a utility knife that he refused to put down. After negotiating with the man for several minutes, Rose deployed a taser and took the man into custody.

On Jan. 21st, Officer Wulker investigated a heroin overdose at a home on Redbird Drive. The 24 year old man was charged with possession of drug abuse instruments.

On Jan. 22nd, an aggravated burglary was reported at a home on Patrick Lane.

During the overnight hours of Jan. 25th, Wholesale Auto Sales was forcibly entered.

On Jan. 25th, a 31 year old man overdosed on heroin at a Gateway Drive home.

On Jan. 27th, a burglary was reported at a home on Snider Road.

During the overnight hours of Jan. 27th, garages were entered and chainsaws stolen from two homes on Clarawill Drive.

On Jan. 29th, a 27 year old man overdosed on opiates at a home on Sterling Springs Drive.

On Jan. 29th, a garage was forcibly entered at an Oakdale Drive home.

On Feb. 3rd, Officers Wulker and Collier investigated the heroin overdose death of a 44 year old man at a Redbird Drive home. The 62 year old homeowner was charged with Permitting Drug Abuse.

On Feb. 10th, Captain Rose investigated a one car crash into the building of Venetian Gardens.

On Feb. 10th, Officer Wolf responded to a Main Street home to check on a six year old child. Upon arrival, Officer Wolf found the child's 39 year old father under the influence of heroin and marijuana. The man was arrested and the child was released to the mother's custody.

On Feb. 15th, a 29 year old man overdosed on opiates at a Crawford Lane home.

On Feb. 18th, Officer West investigated a live grenade found in a shed at a home on Melody Lane. The Hamilton County Bomb Squad responded and removed the device.

Some Significant Incidents February 2014—March 2014

On Feb. 21st, a vehicle was taken for a test drive from Wholesale Auto Sales. The two men test driving the car failed to return. Captain Rose arrested the men after they returned from Florida with the car three days later. They were apprehended at Phipps Auto selling stolen batteries for scrap. They were also found in possession of three stolen license plates.

On Feb. 23rd, Officer McFarland was sent to a Marsh Circle home to attempt to locate a vehicle and driver that fled from Cincinnati Police on a traffic stop, nearly running over two officers. While at the suspect's home, the vehicle was observed driving down the street and McFarland initiated a traffic stop. The 25 year old driver was intoxicated and arrested for OVI.

On Feb. 24th, a sexual assault of a 5 year old boy by a known person was reported.

On Mar. 4th, a burglary was reported at an apartment at Country Lake.

During the overnight hours of Mar. 6th, several unlocked vehicles were stolen from in the Four Seasons subdivision.

On Mar. 7th, a burglary was reported at a home on Gibson Road.

On Mar. 9th, Officers McFarland, Wolf, and Wulker responded to a home on Manila Road for a reported verbal disorder. Five teens ages 15-18 were charged with underage consumption and one of the teens was charged with possession of marijuana and drug paraphernalia.

Captain Rose located the 52 year old female who was overdosed on opiates. She was transported by EMS to the hospital and charged with OVI. 12 hours later, after being released from the hospital, she drove again and crashed. The Ohio State Highway Patrol charged her with another OVI.

On Mar. 20th, a 17 year old boy was caught shoplifting at Kroger. The boy assaulted the loss prevention officer in an attempt to get away. Officer West arrested the boy and charged him with robbery.

On Mar. 23rd, thee men, ages 19-24 jumped a 19 year old man and 21 year old woman at a home on Parkwood Drive. The female was knocked unconscious during the assault and was transported by EMS to the hospital. Officer Bucksath charged the three men with assault and inciting violence.

On Mar 24th, a parent reported that his 12 year old daughter was receiving nude photos and videos from adult males via social media.

On Mar. 25th, Officers Wolf and West arrested two brothers ages 43 & 46 that were caught shoplifting at Kroger. The younger was also charged with having a heroin syringe.
