Significant Criminal Cases

The murder case of three year old Brooklyn Upton from 1785 SR28 is pending trial; Samuel Johnson is incarcerated on a murder charge for her death.

On April 3rd on Edenton Pleasant Plain Road, a female reported that her grandfather has repeatedly drugged and raped her over the past five years. This case was closed with the arrest of Donald Fisher.

On May 10th on Redbird Drive, a woman's ex-boyfriend forced his way into her residence and beat her with a crow bar, he drug her from the home before fleeing after being confronted by a neighbor. The investigation determined that the suspect, Jeffrey Smith likely intended to murder her. He has been arrested and indicted on multiple counts including attempted murder.

On June 4th on Carol Court, Michael Fields was arrested after he threatened another man first with a machete in hand and then he obtained a rifle.

On June 6th a woman was robbed at gunpoint on the parking lot of Kroger. The suspect is at large.
