This property is now in foreclosure with  $5/3^{rd}$  Bank who will be responsible for the clean up. The Chairperson Tom Risk asked if Combs looses the property can the board rezone the property to B2....Lou Ethridge suggested that the board rezone it to a Planned Development Commerce, which is a new classification which gives the township more control and the land owner a bit more flexibility to what they can do.
