### Specifications:

- 1. Building footprint = 4600 sq. ft. (48' X 96')
- 2. Building ht. = 24' 10"
- 3. Front setback Wood St = 2 Ft. (approx.)
- 4. Rear setback Dentist = 2.77 Ft (approx.)
- 5. Right setback Alley = 1.35 Ft. (approx.)
- 6. Left setback St Rt 28= 150 Ft. +
- 7. Colors = Generally as shown with Wainscot either brick or cultured stone on front of building
- 8. Allowable deviations: as required by engineering and as required by Building Dept., or other regulatory bodies.

### **REQUESTS:**

- 1. Parallel parking stalls associated with this project along Wood St shall be enforced as 1 or 2 hr parking
- 2. No township permit fees for road work or work in right of way
- 3. Possible need for short term road closing of Wood St for construction
