

Goshen Township
New Driveway / Replacement / Inspection

PLEASE READ ALL REGULATIONS CAREFULLY
(Make checks payable to the Goshen Township Trustees)

New Driveway: Fee - \$75.00

The Goshen Township Trustees require the installation of a Driveway Drainage Facility of a size, length, shape and type as determined by the Goshen Township Service Director.

The Goshen Township Trustees require a 150 feet setback from intersecting streets or roads starting from the edge of the pavement. If a property, because of its size, cannot meet the required setback of 150 feet, the Township requires the maximum distance be used according to lot size and what is determined by the Service Director.

The Goshen Township Service Director will notify the applicant within ten (10) days as to the size, length and type of driveway facility required. The Service Director will determine driveway slant.

Replacement: Fee - \$50.00

It is understood that it is the responsibility of the property owner to purchase the culvert pipe to complete the project replacement of the driveway culvert. This agreement is in accordance with the Ohio Revised Code Section 5589.06, which requires the Township to maintain drainage along all Township roadways. The Township will install the culvert tile to assure proper drainage.

The Township requires a 12" x 20' galvanized tile, 20' is the minimum. You may go longer if you wish **however**, there is a \$3.75 charge for each additional foot beyond the 20' minimum. The Township replaces the gravel; **we do not replace blacktop or concrete.**

Inspection: Fee - \$30.00

Prior to pouring the curb cut, you are required to contact the Service Director to come out and inspect the proposed job site. Also prior to pouring the driveway the proposed job must be approved or signed by the Service Director.

REGULATIONS

LOADING OR UNLOADING OF EQUIPMENT AND MATERIAL FROM THE ROADWAY WILL NOT BE PERMITTED.

STORAGE OF PIPE AND MATERIAL ON THE PAVEMENT AND BERMS WILL NOT BE PERMITTED.

NO EQUIPMENT OR VEHICLES, INCLUDING PERSONAL AUTOMOBILES, WILL BE PERMITTED TO PARK ON THE PAVEMENT OR BERMS.

IN THE EVENT IT BECOMES NECESSARY TO WORK FROM THE PAVEMENT, EQUIPMENT AND PERSONNEL OPERATING FROM THE PAVEMENT SHALL BE KEPT TO A MINIMUM WITH ADEQUATE FLAGMAN AND TRAFFIC WARNING DEVICES MAINTAINED AT ALL TIMES.

ALL WALKS, STEPS, DRIVEWAYS, DRAINS, MAIL BOXES, TRAFFIC SIGNS, GUARD RAILS, HEADWALLS, POLES, FENCES, ETC. THAT ARE DISTURBED MUST BE RESTORED TO THEIR ORIGINAL CONDITION OR BETTER.

ALL DITCH AREAS AND SLOPES DISTURBED MUST BE RESHAPED TO DRAINS PROPERLY AND SEEDED OR SODDED AS DIRECTED BY THE SERVICE DIRECTOR.

THE PAVEMENT AND BERMS MUST BE KEPT CLEAN OF DIRT, MUD AND DEBRIS AT ALL TIMES.

LOCAL TRAFFIC FACILITIES, FOR PEDISTRIAN AND VEHICULAR INGRESS AND EGRESS SHALL BE PROVIDED AT ALL TIME FOR THE PROPERTY ADJACENT TO THE WORK AREA.

TWO WAY TRAFFIC SHALL BE MAINTAINED AT ALL TIMES.

PROPER ROADSIDE DRAINAGE SHALL BE MAINTAINED AT ALL TIMES.

ALL AREAS DISTURBED BY THIS OPERATION SHALL BE RESTORED COMPARABLE TO THAT OF THE SURROUNDING AREA AND TO THE SATISFACTION OF THE SERVICE DIRECTOR.

RESTORATION OF ALL AREAS DISTURBED SHALL BE COMPLETED IMMEDIATELY AFTER INSTALLATIONS.

ALL WORK SHALL BE DONE AT NO COST TO THE GOSHEN TOWNSHIP SERVICE DEPARTMENT OR THE GOSHEN TOWNSHIP TRUSTEES.

ALL EQUIPMENT USED ON THE PAVEMENT SHALL BE RUBBER TIRED.

A DRIVEWAY CONSISTING OF A MINIMUM OF 50' FROM ROW SHALL BE IN PLACE BEFORE A DRIVEWAY PERMIT MAY BE OBTAINED.

THE RIGHT IS RESERVED, DURING THE TIME ANY OR ALL OF WORK BEING PERFORMED, TO APPOINT AN INSPECTOR OVER THE WORK WHO SHALL REPRESENT THE INTEREST OF THE TOWNSHIP ON THE WORK, AND ANY COMPENSATION ARRANGED FOR SHALL BE PAID WHOLLY BY THE PERMIT HOLDER. ALL SATURDAY WORK SHALL BE 1 ½ TIMES THE REGULAR PAY; SUNDAYS WILL BE TWO TIMES THE REGULAR PAY FOR THE INSPECTOR.

ALL RULES AND REQUIREMENTS OF O.S.H.A. WILL BE FOLLOWED WHILE WORKING ON THE TOWNSHIP RIGHT OF WAY.

ALL APRONS FOR CONCRETE DRIVEWAYS SHALL BE BLACKTOPPED OR GRAVELED. THERE SHALL BE NO CONCRETE OVER THE DRIVEWAY CULVERT PIPE. THE DRIVEWAY APRON IS BETWEEN THE RIGHT OF WAY LINE AND THE EDGE OF THE PAVEMENT.
