

# Regular Public Meeting of the Goshen Township Board of Trustees Minutes December 3, 2003

The Regular Public Meeting of the Goshen Township Board of Trustees was called to order at 7:00 pm.

Roll call - Ed Soergel - present, Lee Lewis - present, Tim Hodges- present

\*\*\*Lee Lewis made motion and Tim Hodges seconded the approval of minutes from previous meetings on November 5, 12 and 20, 2003. Motion carried.

\*\*\*Tim Hodges made the motion to pay bills and transfer funds to cover expenses as per attached. Lee Lewis seconded. Motion carried.

Oberer Development made a presentation to the Board to request a resolution of support for tax credit. The first phase of the project would be eight buildings with 8 units to a building with primarily 1, 2 and 3 bedroom units. The rent range would be \$356 to \$665 and there would be an income stipulation not to exceed \$38,850. Tim Hodges made a motion to accept the resolution and take the matter under advisement. There was no second for this motion. The motion died.
