Old Business

Bunnel Hill

Chris Weisman gave an update on the completion of the punch list for the Goshen Government Center. The following work authorizations were received by the Board:

- #38 from DAG for an additional \$523.00 for a price increase to acoustical ceiling tile in June.
- #39 from Detillion Fence for an additional \$441.00 for price of cutting gates down and installing spring loaded casters on each gate.
