A letter was received from the Goshen Park District, congratulating the newly elected Trustees and inviting them to attend the Goshen Park District meetings held on the second Thursday of the month at 7:00PM at the former Goshen Township Hall.

#### Finance Report Items

Administrator Ray Snyder stated that he would be meeting with department heads in the coming week to explain to them what the Board of Trustees want included in their monthly reports in regards to their budgets. Ray stated that on the second meeting of every month, he would be providing the Board with a status report for every fund account in each department.

#### Set date for Annual Clean Up Day

#### Clean Up Day bids

Two bids for trash removal were received for the Annual Clean Up day. One quote was from Bavarian and one was from Rumpke. The quote received from Bavarian is a flat rate of \$1,680.00 for (4) thirty-yard open top containers. In addition, the price for the (5) manned rearload trucks is a flat rate of \$2,800.00 plus \$25.75 per ton. The quote received from Rumpke is as follows: \$295.00 per load for 4-30 cubic yard roll off containers and \$119.00 per truck hour plus \$35.00 per ton for 5-rear load manned (compactor style) trucks.

Using the figures from the 2005 Clean Up day, Ray Snyder came up with a total cost of \$5,660.00 for Rumpke and \$6,025.00 for Bavarian.

# Hire part-time fire fighter Mary Willoughby

\*\*\*Mike Keeley made the motion upon the recommendation of Chief Virgil Murphy that the Board hire fire fighter/Medic Mary Willoughby in a part-time position with the Goshen Township Fire/EMS, starting pay \$12.00 per hour. Tim Hodges second-motion carried. Mike-Yes, Tim-Yes, T.J.-Yes.

## Hire part-time fire fighter Dirk Puckett

\*\*\*Tim Hodges made the motion upon the recommendation of Chief Virgil Murphy that the Board hire fire fighter/Medic Dirk Puckett in a part-time position with the Goshen Township Fire/EMS, starting pay \$12.00 per hour. Mike Keeley second-motion carried. Tim-Yes, T.J.-Yes, Mike-Yes.

#### Extend probationary period of Bradley Moore

#### Transfer of Funds

\*\*\*T.J. Corcoran made the motion that the Board authorize transfer of funds in the amount of: \$101,000.00 from account fund 2021-820-820-0000;

\$4,000.00 from account fund 2231-820-820-0000;

\$20,000.00 from account fund 1000-820-820-0000,

to the Capital Improvements 4000 series fund, to be established in the Uniform Accounting Network by the Township Fiscal Officer. The total amount of funds transferred, \$125,000.00, shall be set-aside in that fund for the specific purpose of funding the 2006 paving and curb and gutter replacement contracts. The funds specified in this motion shall remain in the Capital Improvements Fund for a period of one year. Mike Keeley second-motion carried. T.J.-Yes, Mike-Yes, Tim-Abstained.

- \*\*\*T.J. Corcoran made the motion that the Board authorize transfer of funds in the amount of \$5,000.00 from account fund 2011-820-820-0000 to the Capital Improvements 4000 series fund, to be established in the Uniform Accounting Network by the Township Fiscal Officer. The total amount of funds transferred, \$5,000.00, shall be set-aside in that fund for the specific purpose of funding the replacement of cross-road culverts on township roadways during fiscal year 2006. The funds specified in this motion shall remain in the Capital Improvement Fund for a period of one year. Mike Keeley second-motion carried. T.J.-Yes, Mike-Yes, Tim-Abstained.
- \*\*\*T.J. Corcoran made the motion that the Board authorize transfer of funds in the amount of \$10,000.00 from account fund 1000-820-820-0000 to the Capital Improvements 4000 series fund, to be established in the Uniform Accounting Network by the Township Fiscal Officer. The total amount of funds transferred, \$10,000.00, shall be set-aside in that fund for the specific purpose of funding the replacement of signage and other branding efforts along public highways within the township. The funds specified in this motion shall remain in the Capital Improvement Fund for a period of two years. Mike Keeley second-motion carried. T.J.-Yes, Mike-Yes, Tim-Abstained.
- \*\*\*T.J. Corcoran made the motion that the Board authorize transfer of funds in the amount of \$52,000.00 from account fund 2081-820-820-0000 to the Capital Improvements 4000 series fund, to be established in the Uniform Accounting Network by the Township Fiscal Officer. The total amount of funds transferred, \$52,000.00, shall be set-aside in that fund for the specific purpose of funding the replacement of two Ford Police Interceptor vehicles for use by the police department. The funds specified in this motion shall remain in the Capital Improvement Fund for a period of one year. Mike Keeley second-motion carried. T.J.-Yes, Mike-Yes, Tim-Abstained.

- \*\*\*T.J. Corcoran made the motion that the Board authorize transfer of funds in the amount of \$22,000.00 from account fund 1000-820-820-0000 to the Capital Improvements 4000 series fund, to be established in the Uniform Accounting Network by the Township Fiscal Officer. The total amount of funds transferred, \$22,000.00, shall be set-aside in that fund for the specific purpose of funding the purchase of one Ford Quad Cab 4x4 pickup truck for use by the service department. The funds specified in this motion shall remain in the Capital Improvement Fund for a period of one year. Mike Keeley second-motion carried. T.J.-Yes, Mike-Yes, Tim-Abstained.
- \*\*\*T.J. Corcoran made the motion that the Board authorize transfer of funds in the amount of \$200,000.00 from the unencumbered balance currently reflected in the Safety Services Levy fund 2192 to the Capital Improvements 4000 series fund, to be established in the Uniform Accounting Network by the Township Fiscal Officer. The total amount of funds transferred, \$200,000.00, shall be set-aside in that fund for the specific purpose of funding the purchase of one Sutphen brand fire engine, to be placed in service by the fire department. The funds specified in this motion shall remain in the Capital Improvement Fund for a period of two years. Mike Keeley second-motion carried. T.J.-Yes, Mike-Yes, Tim-Abstained.

# **Growth Management Plan**

Corcoran made the motion that the Board of Trustees direct Administrator Ray Snyder to direct the Zoning Commission to solicit information of contracted services from various venders that may provide comprehensive land use planning expertise.
