- \$25,000.00 from fund 2031-820-820-0000

to the capital improvements 4000 series fund, to be established by the Township Fiscal Officer. The total amount of fund transferred shall be set aside in that fund for the specific purpose of funding the following: 2007 debt service and administration building signage, service department rolling stock replacement, service department fleet repairs and roadway repair projects. The funding specified in this motion shall remain in the capital improvement fund for a period not to exceed three years. Mike Keeley – second; motion carried. Mike Keeley – yes, T.J. Corcoran – yes, Tim Hodges – absent.

***T.J. Corcoran made the motion that the Board of Trustees appropriate funds in the amount of \$79,000.00 from the general fund unencumbered balance. Said monies are to the transferred to the capital improvements 4000 series fund, to be established in the UAN by the Township Fiscal Officer.. The total amount of funds transferred shall be set-aside in that fund for the specific purpose of funding park playground equipment construction, the Anchorage roof replacement and the funding of our contract with a planning/consulting firm. The funding specified shall remain in the capital improvements fund for a period not to exceed one year. Mike Keeley – second; motion carried. Mike Keeley – yes, T.J. ***T.J. Corcoran made the motion that the Board of Trustees appropriate funds in the amount of \$41,000.00 from PMVL unencumbered balance and \$45,000.00 from the gas tax unencumbered balance. Said monies are to be transferred to the capital improvements 40000 series fund, to be established in the UAN by the Township Fiscal Officer.. The total amount of funds transferred shall be set-aside in that fund for the specific purpose of funding the purchase of a service department dump truck. The funding specified in this motion shall remain in the capital improvements fund for a period not to exceed two years. Mike Keeley – second; motion carried. Mike Keeley – yes, T.J. Corcoran –yes, Tim Hodges – absent.

***T.J. Corcoran made the motion that the Board of Trustees appropriate funds in the amount of \$25,194.00 from the unencumbered cemetery balance. Said monies are to be transferred to the capital improvements 4000 series fund to be established in the UAN by the Township Fiscal Officer. The total amount of funds transferred shall be set-aside in that fund for the specific purpose of funding the 2007 cemetery mowing contract. The funding specified in this motion shall remain in the capital improvements fund for a period not to exceed one year. Mike Keeley – second; motion carried. Mike Keeley – yes, T.J. Corcoran –yes, Tim Hodges – absent.

The total amount of funds transferred shall be set-aside in that fund for the specific purpose of funding future replacement of durable equipment and also includes 2007 debt service payments on the administration building. The funding specified in this motion shall remain in the capital improvements fund for a period not to exceed three years. Mike Keeley – second; motion carried. Mike Keeley – yes, T.J. Corcoran –yes, Tim Hodges – absent.

*** T.J. Corcoran made the motion that the Board of Trustees transfer funds in the amount of:

- \$7,000.00 from fund 2191-820-820-0000

to the capital improvements 4000 series fund, to be established in the UAN by the Township Fiscal Officer. The total amount of funds transferred shall be set-aside in that fund for the specific purpose of funding future replacement of motor vehicles and other durable equipment. The funding specified in this motion shall remain in the capital improvements fund for a period not to exceed three years. Mike Keeley – second; motion carried. Mike Keeley – yes, T.J. ***T.J. Corcoran made the motion that the Board of Trustees appropriate funds in the amount of \$75,000.00 from the ambulance district unencumbered balance. Said monies are to be transferred to the capital improvements 4000 series fund, to be established in the UAN by the Township Fiscal Officer. The total amount of funds transferred shall be set-aside for the specific purpose of funding the purchase of tools and equipment for engine #18. The funding specified in this motion shall remain in the capital improvements fund for a period not to exceed one year. Mike Keeley – second; motion carried. Mike Keeley – yes, T.J.
